In this edition: Check-in and Check-out times at CMCA RV Parks and caravan parks, dogs, WHS and iPads

Following recent discussions about arrival and departure arrangements across our CMCA RV Park network, we are seeking Custodian feedback on this topic.

Custodians have several roles within the park including checking in guests and taking new bookings, siting vehicles, grounds maintenance, ensuring the place is tidy, coordinating happy hours, ensuring waste management is undertaken effectively, dealing with complaints, as well as having some "own time" to relax or to leave the park for a while.

Most issues arise at our parks during busy times when sites are at a premium and guests are coming and going regularly each day. The question is whether there should be some guidelines around when guests should vacate their site on their last day and when guests should be arriving for their first night.

Custodians who have managed parks such as Bundaberg, Ingham, Innisfail, and Humpty Doo during the peak season understand the pressures placed on our Custodians throughout the day, so does a flexible arrangement work during these months?

Our other parks are much more relaxed, and the current flexible arrangements may suit the parks.

WHS

Workplace Health and Safety is important and CMCA is especially keen to ensure the safety of our volunteers at our RV Parks.

This is a friendly reminder that ALL must wear appropriate PPE when undertaking duties at our parks. This goes for our Custodians as well as other member volunteers.

Thongs are not safety boots... Safety glasses do save eyes. Earmuffs can prevent industrial deafness.

Please let NHQ know if you are missing any PPE equipment at the park so that we can get some for you.



iPads

For those who may not be aware, if you process a booking or payment on the iPad, the last booking details including the guest credit card details will be showing on the screen until it is closed.

Please be careful and do not leave the iPad open for others to see.

Custodian Handover

As mentioned in previous newsletters, this is a critical phase in our RV Park operations. The handover needs to be done effectively and can take a few days to ensure that the new Custodians are up to speed with park management, booking systems, siting, park layout, etc.

Don't forget the Custodian Folder is an important piece of information that needs to be physically handed to the new Custodians. We had a situation this week where a new Custodian was not even aware that the folder existed, let alone where it was being stored.

Dalby, Qld

Following the National Rally in Dalby during 2023, a site was identified, and council has given its support for a CMCA RV Park in Dalby. We are currently preparing the development application with the hope that it will receive a positive assessment, and we might be able to start construction later in 2024.

Tenterfield, NSW

After lengthy delays, we are now preparing to submit a development application for a site in Tenterfield. If all goes well with council consent, it is hoped to start construction later in 2024.
